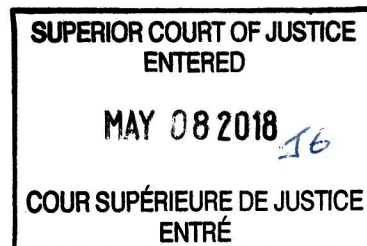

**Schedule "A"**

**TIMETABLE FOR GGC APPLICATION, COURT FILE NO. 07-002/18**

1. This timetable shall apply to the matter of *Girl Guides of Canada-Guides du Canada, et al. v The Public Guardian and Trustee*, court file number CV-07-002/18 (the "Application").

**Timetable for Any Motion for Intervention**

*L.P.*  
2. On or before June 1, 2018, any party wishing to intervene in the Application ("Proposed Intervenor") must provide written confirmation <sup>\* either directly or \*</sup> through their counsel indicating their intention to deliver materials pursuant to this Order (an "Intervention Intention").

3. If no such confirmation is delivered in writing, the Application should be scheduled at the earliest available date that is agreeable to GGC and the PGT.

4. For greater certainty, if an Intervention Intention is not delivered on or before June 1, 2018, an individual shall not have any right to deliver materials as a Proposed Intervenor.

5. On or before June 15, 2018, any Proposed Intervenor must serve on Girl Guides of Canada-Guides du Canada and Pamela Rice (collectively, "GGC") and The Public Guardian and Trustee ("PGT") and file with the Court a Notice of Motion for Leave to Intervene, together with a Motion Record in support of the Motion for Leave to Intervene.

6. On or before July 30, 2018, GGC shall serve on the PGT and all Proposed Intervenors and file with the Court a Responding Motion Record for the Motion(s) for Leave to Intervene.

7. On or before August 6, 2018, the PGT shall serve on GGC and all Proposed Intervenors and file with the Court a Responding Motion Record for the Motion(s) for Leave to Intervene, if required.

8. Cross-Examinations on all affidavits in support of any Motion for Leave to Intervene shall be completed by August 31, 2018.

9. On or before September 7, 2018, all Proposed Intervenors shall serve on GGC and the PGT and file with the Court a Factum in support of its Motion for Leave to Intervene, which shall include the Proposed Intervenor(s) submissions on the Application (the "Proposed Submissions"). The Court shall only consider the Proposed Submissions if Intervenor status is granted.

10. On or before September 21, 2018, GGC shall serve on the PGT and all Proposed Intervenors and file with the Court a Factum in response to the Motion(s) for Leave to Intervene, which shall include GGC's response to the Proposed Submissions as required.

11. On or before September 28, 2018, the PGT shall serve on GGC and all Proposed Intervenors and file with the Court a Factum in response to the Motion(s) for Leave to Intervene, if required, which shall include the PGT's response to the Proposed Submissions as required.

12. On or before October 1, 2018, all Proposed Intervenors shall serve on GGC and the PGT and file with the Court a Reply Factum in respect of its Motion for Leave to Intervene.

13. The Motions for Leave to Intervene shall be heard by the Court Hearing of the Application on October 9, 2018 (1 day). Date Confirmed.

14. GGC's Application shall be heard on a date to be scheduled which is not later than October 26, 2018. ~~At the outset of this hearing, the Court shall determine all Applications for Leave to Intervene.~~
